#### **Updated: Capacity Cleared Price Adjusted for UK Consumer Prices Index**

EMRS, on behalf of <u>Electricity Settlements Company</u> (ESC) would like to inform **Capacity Providers** the circular issued yesterday contained incorrect Capacity Cleared Prices (CCP) adjusted by UK Consumer Prices Index (CPI) for 2020/21 Delivery Year.

The circular has been updated to reflect the correct Capacity Cleared Price (CCP) adjusted by UK Consumer Prices Index (CPI) before the commencement of the 2020/21 Delivery Year. This has been calculated as specified within the <u>Electricity Capacity Regulations 2014</u> (as amended).

This circular provides the adjusted CCP for the T-4 Auctions, including 2018/19, 2019/20 and 2020/21 Delivery Years and where it has been published on the <a href="EMRS website">EMRS website</a>.

#### **Capacity Cleared Price for the T-4 2014 Auction**

The table below illustrates the adjusted CCP for the T-4 Auctions.
