## Implementation date confirmed for the data flows to support EMR backing data

EMRS, on behalf of [Low Carbon Contracts Company](#) (LCCC), and the [Electricity Settlements Company](#) (ESC) would like to advise **Suppliers, CfD Generators** and **Capacity Providers** the implementation date of **30 June 2023**, confirmed for the changes to data flows to support EMR backing data.

The changes will make amendments to the following data flows:

- D0362 - CfD Supplier Invoice Backing Data
- D0363 - CfD Supplier Credit Cover Report
- D0364 - CM Supplier Invoice Backing Data
- D0365 - CfD Generator Invoice Backing Data
- D0366 - CM Capacity Provider Invoice Backing Data

The associated data flows will be structured and named in line with the actual output from the Settlement Systems. This circular provides further details and background information about these changes.

## Who manages the data flow changes and the current position?

The Retail Energy Code Company (RECCo) manage the change process to the industry data flows.

EMRS raised **Change Proposal R0011 - Reporting of Additional EMR Backing Data** and a November 2022 implementation noted. However, LCCC and ESC reviewed their delivery pipeline and determined it is unable to deploy the EMR backing data changes for November 2022. A further change proposal was raised as a matter of urgency, '**R0039 - Revised Implementation data for R0011**' to consider delaying the implementation date to June 2023. This has been through the consultation process to obtain agreement on the revised date and to limit the impacts to industry parties and delivery partners. Following the consultation period and assessment of the feedback received. On 17 May 2022, the RECCo Change Panel confirmed the implementation date as **23 June 2023**.

For those EMR Parties who are RECCo Parties will be able to access both change proposals, **R0011 - Reporting of Additional EMR Backing Data** and **R0039 - Revised Implementation data for R0011**' via the [REC Portal](#).

## What are the next steps?

We will provide further updates and support on these changes over the coming year to support **Suppliers, CfD Generators** and **Capacity Providers** with this change.
