DECC Consultation on BSC Code Subsidiary Documents

This EMR Circular informs you that the Department of Energy & Climate Change (DECC) has launched a consultation to seek views on the modifications to the BSC Code Subsidiary Documents and Configurable Items needed to implement Electricity Market Reform.

What is going to happen?

Amendments are needed to the BSC Code Subsidiary Documents and Configurable Items to ensure successful implementation of EMR legislation. These will be modified by the Secretary of State.

The documents to be modified are:

1. BSCP11: Trading Disputes
2. BSCP15: BM Unit registration
3. BSCP27: Technical Assurance of Half Hourly Metering Systems for Settlement Purpose
4. BSCP503: Half Hourly Data Aggregation for SVA Metering Systems Registered in SMRS
5. BSCP508: Supplier Volume Allocation Agent
6. BSCP509: Changes To Market Domain Data
7. Settlement Administration Agent (SAA) Service Description
8. Supplier Volume Allocation (SVA) Data Catalogue Volume 1
9. Supplier Volume Allocation (SVA) Data Catalogue Volume 2

10. NETA Interface Definition and Design Part 1
11. NETA Interface Definition and Design Part 2
12. Settlement Administration Agent (SAA) User Requirements Specification
13. Supplier Volume Allocation Agent (SVAA) User Requirements Specifications

Who should read this consultation?

This consultation is relevant to BSC Participants and other parties interested in EMR. In particular there are three documents which may directly impact BSC Participants:

1. Changes to BSCP15 may impact you if you are a BSC Trading Party
2. Changes to BSCP503 may impact Suppliers and Supplier Agents
3. Changes to BSCP509 may impact you if you are a Supplier

How does this link to ELEXON EMR Circular 1: BSC Configurable Items amended for EMR?

We published this [Circular](#) on 28 March 2014 to inform BSC Participants of the BSC Configurable Items, which include the BSC Code Subsidiary Documents, amended for EMR, and will be directed by the Secretary of State and included as part of the [June 14 Release](#). This was a commitment we made to the BSC Panel to ensure we are open and transparent about the potential changes needed and to also give BSC Participants the opportunity to comment about the possible impacts ahead of this DECC consultation.

The BSC Configurable Items that DECC are consulting on are the same as the ones published on our website. The exception is that we did not publish BSCP503 and DECC are consulting on BSCP503.
