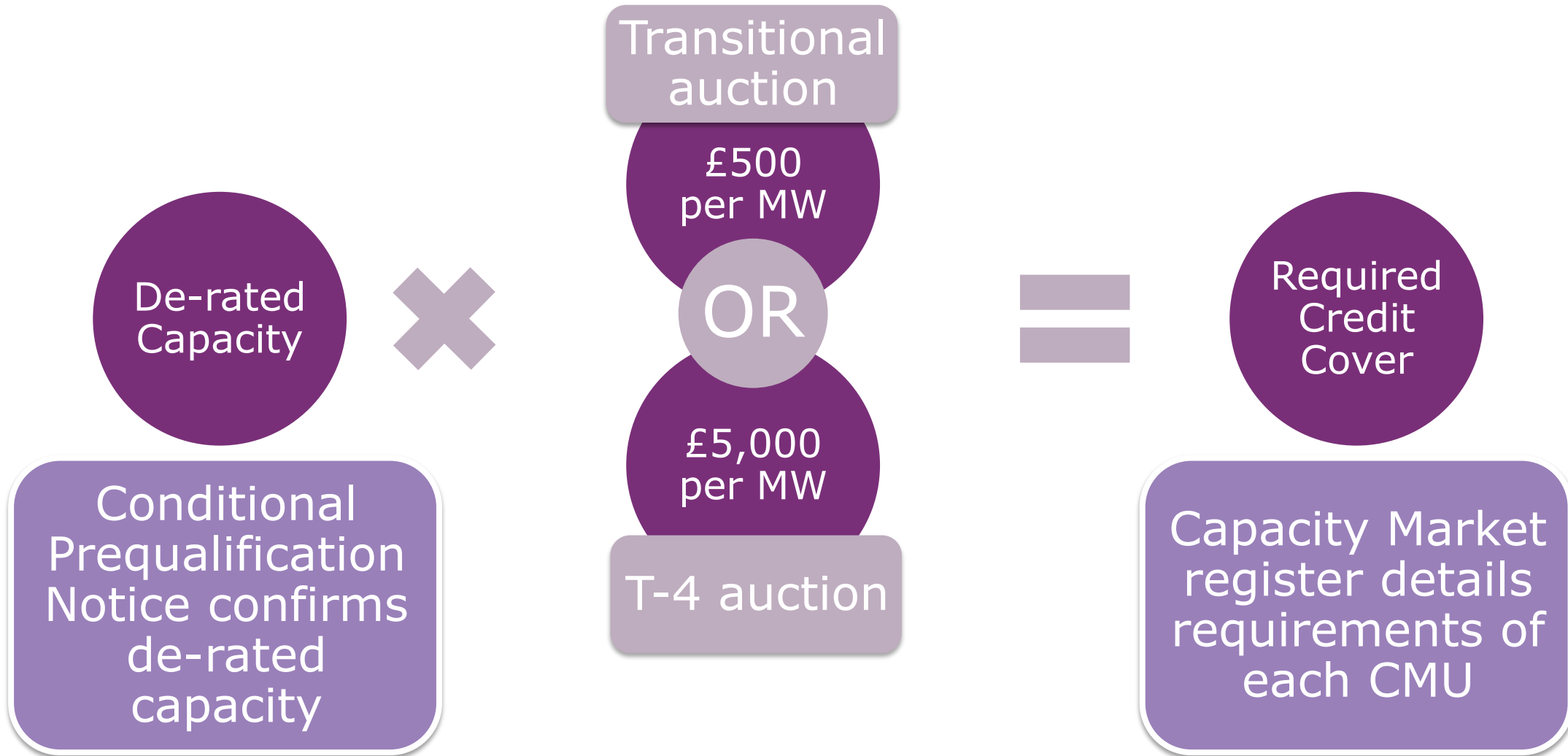

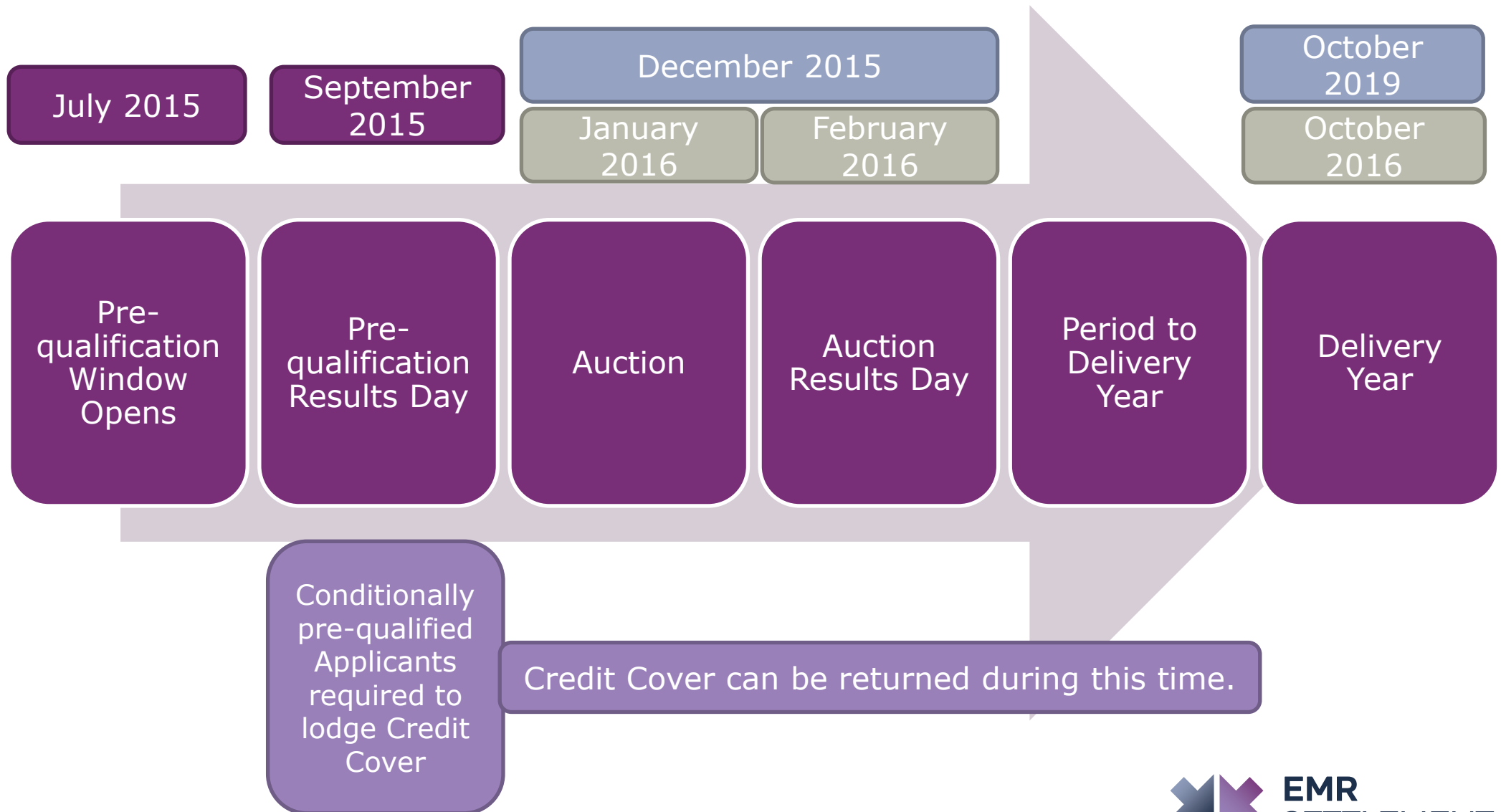

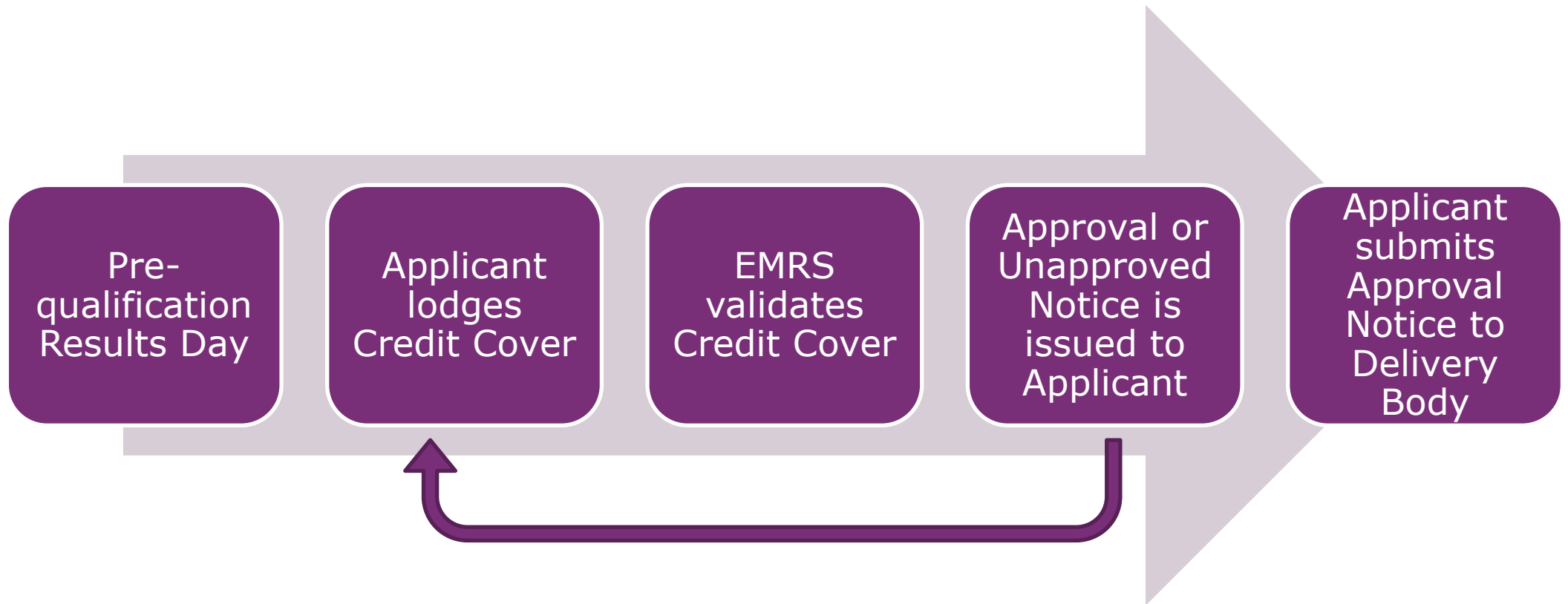
How much credit cover do I need to lodge?

What is the process for credit cover?



- If an unapproved notice is received, an Applicant may have the opportunity to re-submit Credit Cover as long as the overall timescales are met.

What is the credit cover timeline?

Friday 25 September

- Prequalification Results Day

No later than Friday 2 October

- Applicant lodges Credit Cover

No later than Friday 6 November

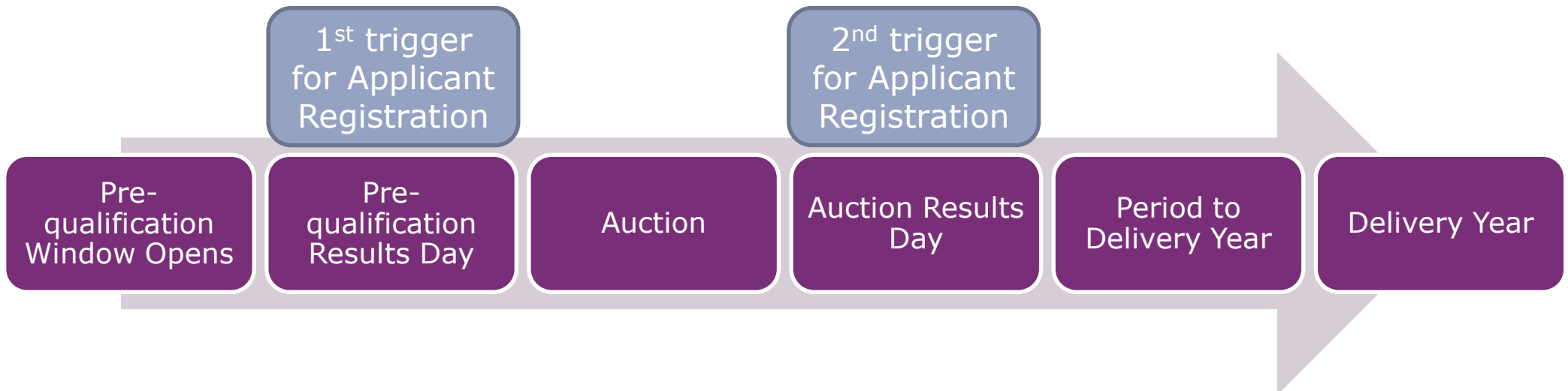
- Receive 'Notice of Approved Credit Cover' or 'Notice of Unapproved Credit Cover' from EMRS

**No later than Tuesday 10
November**

- The latest date the Applicant can provide a copy of the Credit Cover approval notice to the Delivery Body
