Purpose For Information

MRA Change Proposals (DTC CP 3482 and 3483) for EMR has been approved

This circular informs EMR Stakeholders that the MRA Development Board (MDB) at its February meeting approved two change proposals related Electricity Market Reform (EMR), which are:

DTC CHANGE PROPOSAL 3482 - CLARIFICATION OF EMR INVOICE NUMBERS

Who does this impact?

This approved CP impacts:

- Suppliers
- CFD Generators
- Capacity Providers

What does this change implement?

This Change Proposal (CP) amends the description of EMR Invoice Number (Data Item J9150) to clarify that EMR Invoice Numbers are unique within Contracts For Difference (CFD) and within Capacity Market (CM), but not unique across EMR as a whole. As each Settlement Services Provider allocates EMR Invoice Numbers independently of the other, the same EMR Invoice Number may be used by both. This change will assist Suppliers and other recipients of EMR backing data in validating their EMR invoices.

The amended data item is used in the following data flows:

- D0363 CFD Supplier Invoice Backing Data
- D0364 CM Supplier Invoice Backing Data
- D0365 CFD Generator Invoice Backing Data
- D0366 CM Capacity Provider Invoice Backing Data

When will this change be implemented?

This change will be implemented on **30 June 2016**.

DTC CHANGE PROPOSAL 3483 - IMPROVED REPORTING OF CFD LUMP SUM PAYMENTS

Who does this impact?

This approved Change Proposal impacts CFD Generators

What does this change implement?

Data flow CFD Generator Invoice Backing Data (D0365) will be used to deliver CFD Generators with 'backing data' that gives additional information on how their invoices are calculated. The CP changes the 'CFD Ad Hoc Payment' (92I) group of the data flow to allow better reporting of lump sum payments which will assist CFD Generators in validating their EMR Invoices.

The CP adds the following new data items to the 92I group:

- Sustainability Change in Law Amount - this will report any lump sum payments determined under Part F of Annex 7 ('Sustainability Change in Law') of the standard CFD terms and conditions;
- Other CFD Ad Hoc Payment - this will report any lump sum payments that are payable under the terms of a CFD, but not covered by a more specific Data Item;
- CFD Ad Hoc Payment Description – this will be populated with a textual description of the ad hoc payment.
- Compensatory Interest From Date and Compensatory Interest To Date - to allow separate reporting of any compensatory interest payable on a lump sum payment, which will help with validation.

The CP also adds a new Data Item (Total Ad Hoc Payment) to the 87I data group. This will report the total of all Ad Hoc CFD Payments excluding compensatory interest included in the data flow.

These changes will also be mirrored in the CSV backing file.

When will this change be implemented?

This change will be implemented on **3 November 2016**.
